# **Congress Agenda Committee elections**

Please read this brochure to discover more about the candidates standing for election to the Agenda Committee. Statements are published as written by the candidates themselves.

# Those eligible to vote are those registered to vote at Congress on Wednesday 17 May 2023.

If two members have split the voting place on that day (such as one in the morning and one in the afternoon), only one may vote in the election.

Please go to the Governance Desk on the Ground Floor in the Brighton Centre to collect your ballot paper and vote.

Voting is open from 8am to 6pm. It can get very busy so if you can vote outside of the main break times you may find it is quieter and you can avoid a long queue. Don't forget to talk to members in your voting entity to get their views too before making your decision.

Remember, there are four seats up for election and voting is by the transferrable vote method which enables you to cast your vote in order of preference.

The independent scrutineer for these elections, Civica Election Services Ltd, is satisfied that all the following candidates meet the requirements to stand for election.
